NOMINATION FORM AND FOR CONDITIONS OF ENTRY IN THE

2015 KEN WIGHTON SINGLES COMPETITION

Preliminaries:

Conditions of Entry in this competition will be subject to acceptance of the match schedule, rules and conditions of play as set out below. Player's, who place their name on the Nomination Form below, are deemed to have read and agreed to the Conditions as set out below.

All participants may be required to "Mark" *at least one* match of the Match Committee's choice. The Match Committee will allocate markers for the Semi Finals and Final.

Closing Date:

Nominations for this event close on 5pm **Wednesday 21st January, 2015**. with the draw being at least two weeks prior to commencement of the competition .

Eligibility:

1. In order to be eligible to play in any club championship, a player must be a financial member of West Pennant Hills Men's Bowling Section and be registered with the Royal New South Wales Bowling Association at the time of nomination and during the playing of the event.
2. Participants must not have played in an association event for any other club during the calendar year without written consent from RNSWBA Match Committee. (For association events players eligibility rule shall be as per State Conditions of play 2.6)
3. To be eligible to compete in the Ken Wighton Singles Championship, a player must not have won a club Championship, i.e., Minor or Major (whether singles, pairs triples or fours, at this or any other club), or the Ken Wighton Singles Championship (previously called the Novice Singles Championship),

Matches:

All preliminary matches will be played on Wednesday. Depending on the number of entries received, this schedule may require some minor adjustments. There will be 2 trial ends. The current schedule for this competition will be:-

Players who can't play on Wednesdays (due to work) will be permitted to play their game on the Saturday following the schedule round, Card Call 8.40am. Commence 9.00am.

Conditions of Play:

Shall be as per the WPH Men's Bowling Club Conditions of Play. Where not covered by WPH COP then the Zone 10/State Conditions of Play will be used as a guide.

All matches are to be played "**on or before the schedule date** (Rule 5.7.1 WPH COP)" as shown above. Any request for a change of date must be in writing. The Match Committee will consider the request. Such approval **will only** be granted under WPH COP - Rules 5J and 5K

Play or Forfeit Rule

i) The play or forfeit rule will apply at all times with the following exceptions:

- (a) Inclement weather (see section 5j 'Inclement Weather and Safety')
- (b) Any player participating in a State or Zone game or representing the Club (see section 5k 'Replacement Players/Substitutes')
- (c) Long weekend or public holiday (UNLESS by mutual consent of ALL PLAYERS of both teams, the BOWLS CO-ORDINATOR and the availability of an UMPIRE)
- (D) Finals will NOT be delayed more than week. If allowed under WPH Conditions of Play

The Club's dress code is that any player participating in any Club Championship **must** wear the Club 's official Red, White and Blue shirt. **Anyone who arrives to play in the incorrect uniform will not be permitted to take their place in the competition.**

All Bowls in a Team/singles game will have all bowls with either all "**WPH Stickers On**" or all bowls with "**No Stickers On**", failure to abide by this rule may mean disqualification
